Calvin Duncan Wins Clerk of Court Race

In a historic election, Calvin Duncan declared victory as the Clerk of the Orleans Parish Criminal District Court, with 68% of the votes. Duncan was wrongfully incarcerated for 28 years, and spent much of that time in Angola. Also known as the Jailhouse Lawyer, Calvin Duncan is working to create transparency and improve public access to the courts. With such a win for a formerly incarcerated person (FIP), Duncan declared, "I hope that all those people who died in prison because we couldn't get their records are looking down now. I hope they're proud of me. We never stopped fighting for each other's rights, and I will never stop fighting for yours."

Louisiana Citizens for Rehabilitation of Errants (LA CURE), yes, we are coming back even stronger, and our fight continues! One of our members went back to look at what happened at the Capitol in August 2024. We took a giant step backwards in parole and sentencing. **Elections have real consequences.** When we look back at history, the only thing we can say is, "**People didn't go vote,**" by allowing close to 50 years of reform to begin a flush down the drain. Here's what happened: In an Act of Regression, the Louisiana lawmakers have been successful in rolling back sentencing discretionary parole and good time, **basically, doing away with good-time and parole in Louisiana, now people are doing 85% of their sentences.**

So, we have our work cut out for us, with only 29 Democrats on the House side and only 11 Democrats on the Senate side, our fight is real, the passage of HB 9, that went into effect August 1, 2024. While other states are looking at reform, Louisiana is setting sentencing reform back decades! Of course, the current administration is saying it's all about "public safety"! We are about to swell the prisons with thousands of human bodies, that's going to cost us the taxpayers billions of dollars. This seems to be out of touch with other states that are allowing reform to happen, we know that nothing is perfect, it's going to take us all, lawmakers, law enforcement, victims and those people that go astray. I say, let's all educate ourselves on both sides of the coin.

If we have decided to treat people like animals on the inside, my question is, when they are let out, how will they know how to act like a regular human being? Louisiana CURE... Yesterday, Today, and Tomorrow

Approximately 20 years ago when I attended my first Louisiana CURE meeting at the Catholic Life Center, I met some wonderful people who were very passionate and committed about criminal justice in Louisiana. They all seemed to be keenly aware of the conditions inside our prisons, prison policies, to bills introduced up at the state legislature! I realized at that first meeting that I had so much to learn from their wealth of knowledge.

I remember the attendance at those monthly meetings always fluctuating. Relatives of men and women in prison would just show up wanting to find out whatever information they could about their loved one's situation. They would come...and then go...as soon as they found out the information they came looking for. The core members, however, would always be there for every meeting, month after month.

I learned a lot about the criminal justice system in our state by just attending the meetings. I found out who my state representative and my state senator were. I started to pay closer attention on how my elected officials voted on certain bills. I began feeling confident enough to write letters to legislators...and was rather surprised when I started receiving replies from some of them!

After I retired from my job and my schedule allowed, I followed through on suggestions I got from fellow CURE members and started attending several legislative committee meetings...watching the process on how a bill becomes a law – firsthand! Can I tell you...it was quite an education! Sponsors of bills spoke, legislators spoke, and ordinary citizens spoke!

One day, when a bill to abolish the death penalty was being debated in committee...not only did I fill out a green card (which indicates that I am in favor of the bill being discussed) but I also checked off the box requesting to speak before the entire House Committee on Criminal Justice! I DID IT...and it was awesome!

Louisiana CURE has shown me how the system works! Louisiana CURE has given me the tools and the information I need to participate in a system that I was TOTALLY unfamiliar with. That is what an organization like Louisiana CURE is supposed to do – provide information and guidance so I can become a more effective citizen...and they do it well!

AND THEN COVID HIT!

The monthly CURE meetings at the Catholic Charities came to a screeching halt once COVID hit! Attendance at meetings had reached some very healthy numbers before COVID and then the meetings stopped. Gallant attempts to continue meeting through (stay at home) ZOOM meetings proved to be less interactive, and less productive. Month after month attendance (and interest) seemed to diminish. Where did everybody go?
